

LEA Plan for Safe Return to In-Person Instruction and Continuity of Service Pursuant to the Federal American Rescue Plan Act, Section 2001(i)

Introduction and Background

As announced in the New Jersey Department of Education (NJDOE)'s <u>April 28, 2021 broadcast</u>, in March 2021 President Biden signed the Federal <u>American Rescue Plan (ARP) Act</u>, Public Law 117-2, into law. The ARP Act provides an additional \$122 billion in Elementary and Secondary School Emergency Relief (ARP ESSER) to States and school districts to help safely reopen, sustain the safe operation of schools, and address the impacts of the COVID-19 pandemic on the nation's students. As with the previous ESSER funds available under the Coronavirus Aid, Relief and Economic Security (CARES) Act, and the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA), the purpose of the additional funding is to support local educational agencies (LEAs) in preparing for and responding to the impacts of COVID-19 on educators, students, and families. Additional information on ARP ESSER may be found in the NJDOE's <u>funding comparison fact sheet</u>.

Section 2001(i)(1) of the ARP Act requires each LEA that receives ARP ESSER funds to develop and make publicly available on the LEA's website, no later than 30 days after receiving ARP ESSER funds, a plan for the safe return to in-person instruction and continuity of services for all schools (Safe Return Plan) A Safe Return Plan is required of all fund recipients, including those that have already returned to in-person instruction. Section 2001(i)(2) of the ARP Act further require s that the LEA seek public comment on the Safe Return Plan and take those comments into account in finalization of the Safe Return Plan. Under the interim final requirements published in <u>Volume 86, No. 76 of the Federal Register</u> by the U.S. Department of Education (USDE), an LEA must periodically, but no less frequently than every six months through September 30, 2023, review and, as appropriate, revise its Safe Return Plan.

Pursuant to those requirements, **LEAs must submit to the NJDOE and post on their website their Safe Return Plans by June 24, 2021.** The NJDOE intends to make LEA ARP ESSER Fund applications available in EWEG on May 24, 2021 and LEAs will submit their Safe Return Plans to the NJDOE via EWEG. To assist LEAs with the development of their Safe Return Plans, the NJDOE is providing the following template.

This template incorporates the federally-required components of the Safe Return Plan. The questions in the template below will be included in the LEA ARP ESSER Fund application in EWEG. LEAs will submit responses to the questions within the LEA ARP ESSER Fund application in EWEG by June 24, 2021. The NJDOE hopes that this template will allow LEAs to effectively plan for that submission and to easily post the information to their websites as required by the ARP Act.

Note that on May 17, 2021, Governor Murphy <u>announced</u> that upon the conclusion of the 2020-2021 school year, portions of Executive Order 175 allowing remote learning will be rescinded, meaning that schools will be required to provide full-day, in-person instruction, as they were prior to the COVID-19 Public Health Emergency. The NJDOE and New Jersey Department of Health will share additional information regarding State requirements or guidance for health and safety protocols for the 2021-2022 school year as it becomes available.

1. Maintaining Health and Safety

- A. Universal and correct wearing of masks
 - Follow NJDOH guidance regarding masks for students and staff members
 - Require schools to educate and to enforce any required mask wearing
 - o Guide students and staff members in situations where masks are optional
 - Ensure masks are correctly worn when required
 - Require all Visitors to School Buildings to wear masks

 - Follow NJDOH guidance regarding physical distancing for students and staff members
 - Require schools to educate and enforce any required physical distancing
 - Guide students and staff members in situations where physical distancing is optional

- C. Handwashing and respiratory etiquette
 - Follow NJDOH guidance regarding handwashing and respiratory etiquette
 - Require handwashing or hand-sanitizing at designated intervals during the school day, such as before and after eating
 - o Guide students and staff members in situations where handwashing is optional
 - Educate students on the importance of handwashing and respiratory etiquette
- D. Cleaning and maintaining healthy facilities, including improving ventilation
 - Follow NJDOH guidance regarding cleaning and maintaining healthy facilities
 - Adhere to existing required facilities cleaning practices and procedures
 - Continue increased routine cleaning and disinfection, especially to disinfect spaces between cohort groups
 - Follow the manufacturer's instructions for all cleaning and disinfection products (e.g., concentration, application method, and contact time).
 - Sanitize bathrooms daily, or between use as much as possible
- E. Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments
 - Follow NJDOH guidance regarding contact tracing and any resulting need for isolation or quarantine
 - Continue contract tracing designations among school district staff for students, teachers, and other staff members
 - Communicate and cooperate with the local health officials
 - Require Visitors to participate in contact tracing and quarantining as necessary

 - Follow NJDOH guidance and Executive Order requirements regarding testing
 - Educate staff members, students, and families regarding testing

2. Ensuring Continuity of Services

A. Describe how the LEA will ensure continuity of services, including but not limited to services to address students' academic needs and students' and staff's social, emotional, mental health, and other needs, which may include student health and food services. (1000 character limit) The BRRSD will ensure continuity of services to address the needs of students and staff. Students will be supported by a 2021 Summer Learning Program, supplemental before and after school instructional programs during the 2021-2022 school year, targeted tutoring, and school year acceleration academies led by highly effective teachers with a focus on instruction in math, science, and other core content areas. The students' social, emotional, and behavioral needs will be supported by creating a system that provides more universal support in these areas to all students through school-based teams as well as by providing more access to mental health professionals. The district has hired a School Social Worker who will be solely focused on mental health and who will train School Social Worker interns who will provide direct services to students under our dedicated School Social Worker's supervision. For staff members, the professional development offered will continue to balance the instructional needs of educators with their own emotional and mental health needs through strategic design and allowing professional choice when appropriate. Food service will continue to focus on providing nutritious meals that are served in a way that is in accordance with food service guidance and which makes individuals feel comfortable.

3. Public Comment

A. Describe how the LEA sought public comment on its plan, and how it took those public comments into account in the development of its plan. Note, the ARP requires that LEAs seek public comment for each 60-day revision to the plan. (1000 character limit) The BRRSD sought public comment as to the elements of this plan through a survey sent to all parents/guardians. The survey addressed what the respondents felt were the most important elements for the district to include to support students. The survey provided information and named specific interventions that would address the potential academic needs of students, social-emotional needs of students, and health mitigation strategies that the school district might employ for the 2021-2022 school year. The survey allowed parents/guardians to provide opinions about which interventions would be of greatest benefit to their children. The survey data provided a local context for discussions about health mitigation strategies recommended or previously recommended by the NJDOH. At the same time, the local context allowed district educators to fully understand the needs of the community as related to the specific interventions that would most benefit the academic achievement and overall wellness of students. The survey data was reviewed in aggregate by the district administration and will be reviewed by other groups and committees as necessary to revise the plan or to track future changes.

B. Through the use of clear and concise language, the plan was developed to emphasize the priority areas as related to health and safety needs, academic needs, and social-emotional needs connected to school performance and overall mental health. The plan is easily translated through Google and through our school district communication tools. The plan was designed to also easily be reviewed and discussed by the district translator as well as the ADA contact, as needed.
